



Now This Indenture witnessed as follows:

(1) That in order to effectuate his aforesaid desire, the settlor has set apart and handed over to the trustees a sum Rs. 1,00,000/- (hereinafter called the "Trust Fund" which expression shall include cash and any other property or investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time ~~or which may be acquired by the trustees or~~ may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents) and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions agreements and declarations hereinafter contained.

The area of operation of the Trust shall be all over India.

The Trust shall be the Trust for fostering knowledge of applied Science. Technology and Management for their application to growth of economy In general and industrial development in particular.

The main aims and objectives of the Trust are as follows:-

(1) To establish develop, maintain and grant aid in cash or in kind to hospitals, school, medical schools, medical colleges, nursing institution, medical stores, maternity homes, child welfare centers, technical institutions like ITI/ITC, technical colleges like Polytechnic Engineering MBA, MCA, Hotel Management, Disaster Management, B.Ed. and all type of professional colleges and institution (IXth, Xth, XIth, XIIth and other competitive) or such other similar charitable institutions in Indian for the benefit and use of the general public.

(2) To establish, run support and grant aid or other financial assistance schools, colleges, libraries, reading rooms, universities, laboratories research and supply hardware/ software materials to other institutions of the like nature in India, for use of the students and the staff and also for the development and advancement of education and diffusion of knowledge amongst the public in general.

c) To prepare plan and budget of the Trust to borrow and raise money with or without security or on the security of a mortgage, hypothecation or pledge all or any of the immovable or movable property belonging to the organization or in any other manner what-soever.

d) To take loans from Bank/other authorized agencies for furthering the objectives of the Trust.

e) To amalgamate to with any other or organization, institution or association having objects wholly or partly similarly to the objectives of the Trust.

f) The Logo to be adopted by the Trust for its functions will be decided by the Trustee. This Logo will be the Logo for all other units/ subsidiaries of the Trust.

g) To control , direct coordinate, guide and supervise all the institutions running under the Trust.

h) To inspect, check, give proper direction to maintain the books of accounts of the Trust and its institutions and centers.

i) The Trustee audited by the Auditor appointed with the consultation by Board of Trustee.

J) To prepare budget, annual report and balance sheet showing the progress activities and financial condition of the Trust.

k) To take over or amalgamate with any other charitable trust, Society Association or Institutions with similar object.

l) That any Trustees found guilty of dishonesty, carelessness, embezzlement and breach of Trust shall be liable to be removed form Trust by the Board of Trustees.

m) That if the vacancy is caused by death, then in appointment of new Trustee preferences will be given to family members of the deceased Trustee, (Family means the class of relatives as defined in the same order of preference under Section 8 & 9 of the Hindu Succession Act, 1956).

3) The one of the trustee shall have power to spend an amount upto Rs. 10,000/-

Without the approval of the Bard of Trustee, but thereafter all expenditure will require prior approval of Bord of Trustee.

4) To approve the plan, budget, audit report and annual progress report of the Trust and its institutions/Centers.
